

- 1. Sporting Regulations General :-
- 1.1 Title & Jurisdiction:-

The 1997 Welsh Open Formula Ford Championship is organised and administered by BARC (Wales) and Welsh Racing Drivers Association Ltd in accordance with the General Championship Prescriptions of the RACMSA and these championship regulations.

- 1.3 Competitor Eligibility:-
- 1.3.1 Entrants must be fully paid up valid card holding members of the clubs listed in 1.3.2 and in possession of a valid entrants licence.
- 1.3.2 <u>Drivers & Driver/Entrants must be fully paid up members of one of the following clubs. BARC (Wales), Welsh Racing Drivers Association, Monoposto Club, Irish Racing Drivers Association, Peterborough M.C.,</u>

- BARC, BRSCC, registered for the championship and be in possession of a valid RACMSA Competition (Racing) licence to minimum National B status licence or be in possession of a valid licence and medical, issued by the ASN of a member country of the European Union, Monaco, Norway, San Marino, Andora, Iceland or Switzerland.
- 1.3.3 All the necessary documentation must be presented for checking at all the rounds when signing-on.
- 1.4 Registration:-
- 1.4.1 Only drivers registered prior to the event will be awarded points for that event, Registration is by returning the Registration Form and Fee to the co-ordinator. It is the drivers responsibility to ensure she/he is registered.
- 1.4.2 The registration fee is £25.00 Sterling payable to BARC(Wales) & WRDA.
- 1.4.3 Registrations will be accepted from 1st January 1997.
- 1.4.4 Registration numbers will be the permanent competition numbers for the championship.

- 1.6 Scoring:-
- 1.6.1 Points will be awarded to registered competitors listed as classified finishers in the final results as follows:4 or more eligible starters in the class 1st = 4, 2nd = 3, 3rd = 2, 4th = 1 point 3 or more eligible starters in the class 1st = 3, 2nd = 2, 3rd = 1 point 2 or more eligible starters in the class 1st = 2, 2nd = 1 point 1 eligible starters in the class 1st = 1 point Plus one extra point for the competitor(s) achieving or equalling the racefastest lap in the class.
- 1.6.2 Championship positions will be determined by the points totals of the competitors, the maximum number of rounds to count being the total number of rounds less 2. In the event of seven or less rounds being run, all scores will count.

- 1.6.3 Resolving Ties: Ties will be resolved using the formula in Appendix X section 4 of the 1997 RACMSA yearbook.
- 1.6.4 Advertising Competitors will be required to carry advertising as supplied to publicise the championship in accordance with E.2.27.2 in order to qualify for points. Please see regulation 5.7 on page 8 for details.
- 1.7 Awards:-
- 1.7.1 All awards are provided by the championship organisers, in conjunction with the organising clubs where appropriate.
- 1.7.2 Per Round: In each class a trophy
- 1.7.3 Championship: Overall: A trophy. In each class. A trophy.
- 1.7.4 Presentations: Garlands and trophies are to be provided for presentation at the end of each race, or at an end of the meeting presentation ceremony. Prize money and bonuses shall be posted to the Entrants within seven days of the results.
- 1.7.6 Entertainment Tax Liability. In accordance with current government legislation, the BARC Wales and WRDA is legally obliged to withhold the tax at the basic rate on all payments to non-UK resident sports men/women. That is, the persons who do not have a normal permanent residence in the UK. The UK does not include the Isle of Man, Channel Islands or Eire. This means that, as the organiser, BARC Wales and WRDA is required to deduct tax at the relevant rate, currently 24% (23% from 6/4/97) from any such payments they may make to non-UK residents. Under such circumstances, it may be possible for competitors to enter into an agreement with the Inland Revenue to limit the tax withheld. Any application for such an arrangement must be made in writing and not later than 30 days before the payment is due. For further information contact:

 - Class C Formula Ford 1600 for Kent engines
 - Class D Formula Ford 1600 pre 1991 cars with modified Kent engines
